The shareholders may further note that the details uploaded by the Company on its website should be regarded and shall be deemed adequate notice in respect of issue of the duplicate share certificate (s) by the Company for the purpose of transfer of shares to IEPF Authority pursuant to the Rules.

In case of the Company does not receive any communication from the concerned shareholders within three months from the date of this notice, the Company shall transfer the shares to IEPF authority as per procedure stipulated in the Rules.
